# **Common Documents Required for Legal Services**

#### 1. Civil Law

- Identity proof (Aadhaar, PAN, Passport)
- Property documents (if applicable)
- Sale deed/Agreement/Mortgage deed (if property-related)
- Evidence of contract or agreement (if applicable)
- Previous case records (if any)
- Any notices or legal correspondence received

### 2. Consumer Law

- Purchase bill/Invoice of the product or service
- Warranty/Guarantee card (if applicable)
